MD SHA Continues Work on Georgia

State Highway crews will soon begin the final weekend lane closures along MD 97 (Georgia Avenue) in downtown Silver Spring for bus pad construction, bolstering the road surface located directly in front of bus stops to make them strong enough to support heavier vehicles without damaging the roadway. Although workers may not always be present, lanes must remain closed until the bus pad concrete is fully cured (dry) and all affected lanes are declared safe for travel. SHA's contractor will construct the final bus pad on northbound Georgia Avenue at the intersection of Ellsworth Drive. Weather permitting, construction of the final bus pad should be complete by the end of April.

GSSCC Testifies to Keep Tax Dollars Collected from Silver Spring Business Owners in Silver Spring

In an effort to persuade Montgomery County Councilmembers to reject the County Executive's proposal to transfer \$1.1 million out of the Silver Spring Parking Lot District (PLD) budget over the next 15 years, Chamber President Jane Redicker testified recently that the additional tax dollars collected from downtown Silver Spring property and business owners should be reinvested in assuring that Silver Spring's downtown remains clean and safe. She argued that Silver Spring business and property owners who pay a higher level of property taxes because they are inside the PLD expect that those additional tax dollars will support the enhanced level of maintenance and services required in the Urban District, and not be transferred to the County General Fund to balance the budget elsewhere. Redicker also urged Councilmembers to keep the promise made some years ago and sunset the energy tax increase implemented in 2010. Work sessions on these and other County budget matters begin this week.

GSSCC Urges County Council to Sunset the Energy Tax Increase

GSSCC President Jane Redicker was back in Rockville last week, in an effort to persuade Montgomery County Councilmembers to reject the County Executive's efforts to make the energy tax increase a permanent stream of revenue for the County, instead of sunsetting the 2010 increase as promised. Redicker told Councilmembers that in order to create long-term stability for the County's fiscal needs, it should adopt measures that will retain current businesses, attract new ones, and create more jobs, instead of continuing policies that make it more difficult and more expensive to do business here. She pointed to record high vacancy rates in commercial office buildings as evidence that having the highest energy tax in the region is having a major impact on economic development here. She also cautioned that the Federal government – the target of this tax – is reducing its footprint in Montgomery County, explaining that, "By the end of 2015, Federal government leases on more than 3 million square feet of office space here are due to expire. While neighboring jurisdictions work hard to lure these facilities away, and, the Federal Government looks to cut costs, the notion that targeting Federal facilities with a local energy tax seems at best misguided, and at worst, could be a disaster if the Feds decide they are exempt from local taxes."
