Dear Council President Friedson and Members of the Council:

On behalf of the Greater Silver Spring Chamber of Commerce, representing more than 300 employers, mostly small businesses and non-profit organizations in greater Silver Spring and surrounding areas in Montgomery County, we recommend against supporting Bill 42-23, Menstrual Products Access and Equity Act as currently drafted. While we commend the good intentions of the bill, the GSSCC asks that the Council oppose this bill and consider other proposals that would have a positive impact on period poverty.

Since the first letter of opposition the Chamber submitted, it has come to light that this bill is now being directed towards County buildings and the opposition from the County Executive has been swift and articulate in that the County can't afford to take this endeavor on and there is no way they can monitor the adherence if passed. The Chamber concurs with this. In truth, this is a much broader issue than Montgomery County accessibility.

We contend that this bill is not necessary. The State of Maryland already requires that all middle and high schools provide menstrual products in their restrooms. Furthermore, Maryland reduces the costs of menstrual products by exempting those items from the State sales and use tax. It is also our understanding that a significant number of businesses and non-profits already provide menstrual products at their own expense or through partnerships that allow them to do it affordably.

The GSSCC is also concerned about the bill's unknown expense to businesses. It is not difficult to imagine a scenario where free menstrual products in a business are taken on a consistent basis instead of as needed. In that scenario, small businesses in particular face high costs to keep menstrual products available, and the specter of a significant fine as mandated by Bill 42-23.

Bill 42-23, in our estimation, brings with it unintended consequences for the County's economy. Businesses are already facing a growing list of requirements they must adhere to via new laws and regulations. This proposal, which contains confusing language as to what restrooms even fall under this mandate, further complicates the environment that faces Montgomery County businesses. Ultimately, additional mandates on businesses harm the County's competitiveness and add yet another requirement that does not exist statewide or in virtually every other nearby jurisdiction.

Lastly, the GSSCC wants to caution the Council that if there is movement forward on this bill, we see the potential for a slippery slope of other health-related products to be deemed a "public need." Is the Councils expectation that the business community become suppliers/provides of various products, on top of the services they are already providing, and at their own expense? Once again and to the point above, The Greater Silver Spring Chamber of Commerce would like to urge the Council to consider the message that this sends about doing business in Montgomery County.

If the County is interested in doing impactful legislation, there are a number of other initiatives like, lighting – both decorative and safety, - cameras and additional security features in garages, streetscape improvements, and others that would make a greater impact on the Silver Spring community.

We appreciate the opportunity to weigh in on Bill 42-23 and ask that the Council consider other options to address issues regarding period poverty. In conclusion, both the County and many private entities have made enormous investments in Montgomery County. We believe that the position presented in this letter will serve to protect those investments and help to assure a safe, secure, and vibrant future for Silver Spring and Montgomery County as a whole.
